Since the Meeting is being conducted through the VC/OAVM Facility, the Polling Paper as prescribed under Form SH-12 of the Rule 21 of the Companies(Management and Administration) Rules, 2014 will not be made available.
- 5. The link for VC/OAVM Facility through which 24<sup>th</sup> AGM will be conducted, being two-way teleconferencing or webex will be shared with you in an electronic communication being sent along with the Notice of 24<sup>th</sup> AGM.
